Law that declares and defines the boundaries of the Biosphere Reserve Ometepe Island. Its goal is to declare Ometepe Island as a Biosphere Reserve recognized and incorporated into the World Network of Biosphere Reserves of the United Nations for the Education, sciences and Culture- UNESCO, under the program on Man and the Biosphere, in accordance with resolution of June 2, two thousand ten, also defines the limits of the system itself and its administration. Sustainable Rural Tourism Law of the Republic of Nicaragua. Its goals is to promote the formulation and implementation of guidelines and actions that contribute to the development of tourism in rural areas of the country with a focus on sustainable development, encouragement and development, in order to contribute with the inhabitants of rural communities in general and indigenous and African descent in particular involving the exploitation of natural resources and improve living conditions , poverty reduction, recovery and strengthening of their culture. Administrative Provision No.03-2013

Partial Modification of the General Administrative Provision No. 03-2013. The Income General Director, in exercise of his power, dictates the reform of the first Ordinal that will be read: From January, 2013 responsible taxpayer retainers of IR inscribed in the Electronic Window must file their withholding statements at the source, uploading and transferring it to the DGI database, through the procedure described in the 'GUIDE TO IMPORT AND DECLARE INFORMATION' available on the DGI website www.dgi.gob.ni. And the second ordinal will be read: the unregistered taxpayers in the Electronic Window must use form No. 122 called 'MONTHLY WITHHOLDING' available for reference in www.dgi.gob.ni.
