LAW N° 884 "LAW OF AMENDMENTS AND ADDITIONS TO SPECIAL CONTROL ACT AND REGULATION OF CASINOS AND GAMES ROOM." "It is necessary to move related to the regulations of Casinos and Gaming Rooms, a most appropriate institution for this type of service companies, whose purpose is to gainful activity, is determined as implementing authority to the Ministry of Finance and Public Credit who will be responsible for running, observe and enforce the law." LAW N° 886 "ACT STATEMENT OF GARÍFUNA'S CULTURE INTANGIBLE CULTURAL HERITAGE OF THE NATION" "In the framework of the Convention for the Safeguarding of the Intangible Cultural Heritage, UNESCO made the "Proclamation of Masterpieces of the Oral and Intangible Heritage of Humanity" and the Garifuna people of Central America in 2001 at the request of the Government Belize, with the support of the governments of Nicaragua and Honduras request that the "language, dances and music of the Garifuna", a masterpiece of cultural heritage to be included in the Proclamation, the only Central American expression of a transnational community afro descendant who has achieved important distinction." LAW N° 443 "LAW OF EXPLORATION AND EXPLOITATION OF GEOTHERMAL RESOURCES" AND ITS REFORM". "This Act aims to promote and establish the basic conditions that regulate the exploration and exploitation of geothermal resources in the country for exclusive power generation." LAW N° 887 AMENDMENT ACT OF LAW No. 851 "ANNUAL BUDGET ACT OF THE REPUBLIC OF NICARAGUA 2014" AND ITS REFORM LAW N° 877 AMENDMENT LAW OF LAW N° 851 "ANNUAL BUDGET ACT OF THE REPUBLIC OF NICARAGUA 2014". "In order to increase the General Budget of Expenditures for the financial year 2014, increasing budgetary allocations to ministries and institutions such as the Ministry of Health, Ministry of Transportation and Infrastructure, Secretary of the National System for Prevention, Mitigation and Response disaster Army of Nicaragua. LAW N° 225 "METROLOGY LAW AND ITS AMENDMENTS". "To establish the principles, norms, rules and general tools needed to create and operation of a program aimed at reducing risks through prevention activities, mitigation and disaster agency system, whether natural or induced." MINISTERIAL AGREEMENT N° 23-2014 "RULES OF DEMATERIALIZED AND STANDARDIZED ELECTRONIC AUCTIONS OF GOVERNMENT SECURITIES". "This law regulates the training process of financial resources by placing standardized dematerialized government securities and denominated Treasury Bills, Bonds of the Republic of Nicaragua and Bonds of the Republic of Nicaragua and Bonds Redeemable Republic of Nicaragua, which placed through competitive and non-competitive auction to undertake the NCB in its capacity as fiscal agent of the MHCP, using the Electronic auction System".
